Seasonal Notes

As Winter is still upon us, here are some reminders repeated from last month.

Holiday Absence: If you are going to be away for any of the holidays, leave your central heat running and the thermostat set in the 45F-50F degree range. It is also worth leaving cupboard doors open where pipes are running near outside walls, to ensure the heat from the air gets to the pipes.

Hoses: Please ensure hoses are unhooked, and water drained from the spigots. Repairing water damage is expensive, and messy.

Snow Removal: our staff do a great job plowing snow on the parking lots and sidewalks—but sometimes mis-parked vehicles, by the curb or over-hanging from the car ports, get in the way. The Board has approved Rules (see November Board meeting report) imposing penalties for hindering snow removal.

Play Ground Committee

It may be remembered that an *ad hoc* committee was formed last year to deliberate on the state of the Mountain Shadows playground area, and took action removing dangerous and dilapidated equipment, fixing what could be repaired, and planning for bringing our playground into the 21st Century.

Workdays were held before the Fall/Winter season set in, resulting in dismantling the much-loved but collapsing merry-go-round, the fitting of new swings, and the replacement and refinishing of the woodwork on the "pirate ship."

The Board has allocated some further funds, to support planning efforts going forward, and perhaps to start some further work.

To bring this about, a planning meeting, led by Board Members Jennifer Simpson and Thomas Harris, is being scheduled for Monday, February 1, at 7:00 PM, in the Clubhouse. At this meeting, ideas and suggestions will be considered for work to be done this coming Spring and Summer.
